#### 2023 Edition – Promoting Person-centred Care

The theme for the 2023 edition of the European Social Services Awards was 'Promoting Person-centred Care'. Under this year's theme, the Awards recognised the organisations and people that are rethinking their services to provide care which is centred around the person, coordinated between services and professionals and enables people to live independent lives and be fully included in their communities.

Any organisation involved in social services that has a project demonstrating that the project promotes person-centred care, is innovative for their respective context/environment, and has a positive impact could apply. Award winners are determined in a two-step process that combines an expert judging panel's selection with an online social services community vote. ## Coffee and Community: Tackling Rural Isolation

Rural Coffee Caravan, United Kingdom

The Rural Coffee Caravan's project addresses the isolation and loneliness of older people in rural areas, which often leads them to feel disconnected in their communities.

 AST Contact Points for People with Qualifications Gained Abroad - Counselling Centre for Migrants in Vienna, Austria

AST Contact Points simplifies the process of recognising foreign qualifications. This has allowed individuals from over 170 countries to fully use their professional diplomas and enter the Austrian labour market, easing skills shortages.



Geronto Community - Home for Older People Centre, Croatia

Mobile team consisting of a nurse and social worker who offer holistic and individualised support, including emotional, social, and health counselling in older peoples' own homes.





• Live in Dignity - Pro-ACT Support Association, Romania

This programme supports adults with intellectual and psycho-social disabilities, who are currently living in large residential facilities, to move to smaller, family-like homes and flats in rural areas.



Pathways to Freedom - SOS Children's Villages, Bulgaria
Psychological and professional development support for young people leaving care in their transition to independent living in Bulgaria.



 Person-centred Value Framework for Specialist Social Services - Region of Southern Denmark

Improving the autonomy, self-reliance, and quality of life for individuals in specialist social services facilities through a values-based framework.



 Silver DOST – Respect for All Ages - The Agency for Sustainable and Operative Social Provision (DOST Agency), Azerbaijan

This programme helps to address unmet needs amongst older people, including those with limited self-care abilities or facing psychological challenges, to overcome social stigmas that limit their potential.

## Workforce Support

PYCIPEDIA: Knowledge Sharing Platform to Connect Specialist Social Workers

Linköping Municipality R&D Centre, Sweden; IT University of Copenhagen, Denmark

A wiki-type collaborative platform developed to allow social workers across Sweden to connect, create, browse, and share training materials with each other and with parents of children with intellectual disabilities.



## **Shortlisted Projects**



 Developing a Communication and Person-Centred Practice - Northern Health and Social Care Trust, United Kingdom

This project provides training in Talking Mats and Makaton for health support and social care staff working with persons who have difficulty with or cannot communicate verbally.




 Dialogical Approach to Care - Department for Social Rights, Regional Government of Navarra, Spain

## Collaborative Practice

A cornerstone of person-centred care is the coordination between relevant organisations, services, and sectors to ensure the needs of people are met. This Award honours cooperative relationships between different levels of government, public agencies, services, third and private sector organisations that have led to the provision of person-centred care.

## Winner

#### The Sharing Factory

Public Centre for Social Welfare, Kortrijk, Belgium

A collaboration between government agencies, third-sector organisations, and volunteers, to offer items such as clothing, household appliances, and bikes for shared or temporary use, alongside support to people in need.

Community-based service providing essential day-care for people with psycho-social disabilities, helping them access other resources in the community and prevent institutionalisation.



## Digital Transformation

Digitalisation and technological tools can play a central role in delivering personcentred care and empowering people. This Award recognises technological and digital improvements that enable social services to provide care that is personalised, coordinated and enabling.

## Winner

Automating Social Protection for Internally Displaced Persons in Ukraine

Ministry of Social Policy, Ministry of Digital Transformation, Medirent, Ukraine

Development of a new platform which centralises appointments and payment processes, supporting almost 2.5 million internally displaced people, enabling the government to monitor their social protection efforts.

 Person-centred technology that identifies changes in daily routines to provide early indicators for various risk situations.



 Al-based Solution for Targeted Social Assistance - State Social Protection Fund, Azerbaijan

Using Artificial Intelligence to centralise and streamline the assessment of people's eligibility for social support, making the process more objective, efficient, transparent, and cost-effective.

## Digital Transformation



 Centria HealthLab - Centria University of Applied Sciences, Finland

A network that connects social and health care professionals, technology companies, non-profit organisations, and end-users, to co-develop technology that promotes well-being and independent living.



 DARE: Data for Integrated Care in Catalonia - Ministry of Social Rights, Ministry of Health, Catalan Government, Spain

Integrating health care and social services' data to better support the needs of an ageing population, while fostering collaborative practice.



 Digital Streetwork Bavaria - Bavarian Youth Council, Germany

Digital anonymous and confidential counselling service for young people that also establishes connections with local social services, bridging the digital and analogue worlds.



 Kujawsko-Pomorskie Telecare - Regional Centre for Social Policy in Torun, Poland

Telecare and social assistance for older people including wrist bracelets equipped with sensors, which are monitored by paramedics to provide support based on individual needs.



 National ICT Services: Providing Quality Client Data for Evidence-Based Social Services - Finnish Institute for Health and Welfare, Finland

Integrated digital social welfare services designed to improve access to, and the quality of clients' social and health data, enabling efficient and accurate care and support.



#### Research and Evaluation

Without a proper understanding of how a social problem arises, it can be difficult to come up with the right solution to address it. Backed with data, research provides this link to social services. This Award honours research that contributed to the development of evidence-based person-centred services.

## Winner

#### Through the Eyes of the Child

The Child and Family Agency (Tusla); Trinity College Dublin, Ireland

This research studied children's experiences of the child protection system in Ireland. The recommendations from the study have led to the introduction of staff training and informed future policy and research work.

 Community Resource Assessment Tool for Social Service Provision - Rehabilitation Centre for Stress and Trauma, Croatia

Tool to help municipalities assess the potential demand for essential social services, simplifying their delivery and enhancing their quality.



Dementia Friendly Helsingborg - City of Helsingborg;
 Lund University, Sweden

The creation of dementia-friendly public spaces that are easy to access and rich in sensory experiences so that people can continue to engage in their communities.

#### Research and Evaluation





 Empowerment-based Services in Domestic Violence -Home for children and adult victims of domestic violence 'Duga-Zagreb', Croatia

This study evaluated the effectiveness of psycho-social services provided to women victims of domestic violence by gathering insights directly from those affected.



• Evaluation of the Home Care Service in Catalonia - Ivàlua: Catalan Institute for Evaluation of Public Policies, Spain

This evaluation analysed strategic policies and gathered evidence to improve and adapt home care in Catalonia to increasingly diverse and expanding care needs.



HARREMANETAN OINARRITUTAKO ARRETA ATENCIÓN CENTRADA EN LAS RELACIONES  GIZAREA: A Relationship Centred Care Model -Department of Social Policies, Provincial Council of Álava, Basque Country, Spain

This project evaluated a care model for people with dementia bringing together professionals, residents, and families to appreciate the importance of their relationships with others.



 InCARE: Community-based Long-Term Care Services -Matia Institute, Spain

This research project looked into the impact of integrated long-term care policies and services for family caregivers of people with dementia. The evaluation helped come up with a roadmap to person-centred long-term care.



Sharing the Voices of those who are Institutionalised to Change Practice and Policy - The University of Birmingham; Changing our Lives, United Kingdom

This research used person-centred principles to study the care of people with autism and other learning disabilities, which aims to influence practice through specific guidance for health and social care leaders.
